#### Abstract:

The aim of the Collaborative Governance research in social protection policy in Karimun Regency is to explore and analyze the process and dynamics of collaboration among various parties in implementing social protection policy in Karimun Regency, as well as to evaluate the effectiveness and efficiency of applying Collaborative Governance in social protection policy. Qualitative research method is employed in studying Collaborative Governance in social protection policy by Karimun Regency, which can be carried out in several stages. The purpose is to understand how the collaboration process between various stakeholders takes place in developing social protection policy. The results show that based on the concept of collaboration in Collaborative Governance, we can imagine that social protection policy in Karimun Regency involves the participation of various related parties, such as government agencies, communities, NGOs, and private sectors. This collaboration aims to achieve better outcomes in social protection in Karimun Regency by applying participatory, inclusive, and transparent principles. #### INTRODUCTION

Since the outbreak of the Covid-19 pandemic in March 2019, local governments throughout Indonesia have been faced with similar challenges, namely public health and significant economic impacts (Solina et al., 2021). The Regency of Karimun in the Kepulauan Riau province has also experienced the same in which the local economy is declining, particularly in the tourism and trade sectors. The Karimun Regency government has renewed its social protection policy amidst this pandemic to ease the burden of affected communities. This article will discuss the social protection policy conditions in Karimun Regency after Covid-19, including the said policy and efforts carried out by the local government to protect the community and restore the regional economy. The social protection policy conditions in Karimun Regency can be divided into two categories, social assistance and fiscal restructuring.

Firstly, social assistance in Karimun Regency is given in various forms such as cash and non-cash assistance. The cash assistance is given in the form of electronic money to families affected by Covid-19, while non-cash assistance is distributed in the form of basic necessities that are given to those in need (Iping, 2020; Rizki et al., 2021). Secondly, fiscal restructuring aims to improve long-term lifestyle and economy by reevaluating resources and identifying new resources in Karimun Regency. It focuses on increasing the production of local goods and services and boosting the competitiveness of the local community and economy. The purpose is to create new job opportunities and improve community welfare (Nawawi, 2021; Supriyanto et al., 2014). In addition, the Karimun Regency government also improves public health facilities such as building hospitals and other health facilities while striving to increase the community's ability to face pandemic situations by providing education on health protocols and distributing personal protective equipment (Kristanti, 2021; Muhtar, 2015).

Karimun Regency government continues to make social protection efforts in the midst of Covid-19 outbreak by providing both cash and non-cash assistance. Additionally, fiscal restructuring is another solution in restoring the regional economy. Providing access to health care and education on health protocols are additional social protection measures. However, it should be noted that social protection policies are unevenly distributed and not fully effective across all levels of society in Karimun Regency. Thus, there is a need for more systematic efforts in the future. Collaborative governance is a form of decision making and policy implementation that involves participation from various parties involved in a particular issue or policy.

In the context of social protection policy in Karimun Regency in Kepulauan Riau province after Covid-19, collaborative governance plays an important role in ensuring the effectiveness and efficiency of social protection policies. In a pre-research study, the researchers found a phenomenon that Firstly, collaboration between the local government, community, and related stakeholders such as civil society organizations and businesses would enable accurate and efficient problem identification. This can ensure that policies taken are truly relevant and reach the right target (Holzmann & Jørgensen, 2001; Warfa, 2019). Secondly, collaborative governance can also increase the accountability of implemented social protection policies. With active participation from various parties, the policies taken will be more transparent and open, enabling the community to participate in

monitoring the government's performance in implementing these policies (Howells, 2018; Xenia, 2014).

Thirdly, collaborative governance can also increase the effectiveness and efficiency of implementing social protection policies. In the post-Covid-19 pandemic situation like the current one, many people have been affected and need quick and accurate assistance. With collaboration from various parties, the government can ensure that the assistance provided will reach the community in a timely manner and no one will be left behind (Devereux, 2021; Razavi et al., 2020). Therefore, it is important for the Karimun Regency government to implement collaborative governance in social protection policies after Covid-19. Collaboration between the government, community, and related stakeholders will strengthen social solidarity and increase the effectiveness of social protection policies for those affected by Covid-19 in Karimun Regency.

Geographic location consisting of 218 islands and a population of approximately 240,000, the Karimun Regency government has initiated a social protection program to assist those in need since 2021, particularly in the frontiers and outermost regions. The program focuses on improving community life quality through economic empowerment, education, health, and providing social assistance to vulnerable groups such as the elderly, people with disabilities, and orphans. Implementation of this social protection program uses a Collaborative Governance approach, involving all parties in the decision-making process and policy implementation (Alika, 2020; Kurnianingsih et al., 2020). Karimun Regency government collaborates with civil society organizations such as NGOs and community groups to conduct surveys and identify people who require social assistance (Barrientos & Hulme, 2008; Merrien, 2013).

### **METHODOLOGY**

The research method employed here is qualitative (Bungin, 2007; Sugiyono, 2016) in analyzing the social protection policy in Karimun Regency, located in the Kepulauan Riau Province. The theory utilized in this research is Ansell and Gash's (2008), which puts emphasis on the involvement of different actors in the decision-making process and the implementation of policies. There are several steps involved in this study. Firstly, identifying and establishing a collaborative network between local government, community organizations, private sector, and society as a whole. This network will work together in designing, implementing, and evaluating social protection policies in Karimun Regency.

Secondly, various stages of participation involving all stakeholders will be included in this research. These stages may entail open meetings, group discussions, or interviews with relevant parties. Active participation from all parties is expected to generate better solutions and encompass different perspectives. The research will then analyze the data and information gathered during the participation process. This analysis will involve a comprehension of the needs and issues faced by the community in Karimun Regency concerning social protection; thus, resulting policies can provide an ideal impact.

#### **RESULTS AND DISCUSSION**

Collaborative Governance, as outlined in the concept of Ansell & Gash, is an approach to public management that focuses on collaboration between stakeholders in addressing complex public problems. The findings and discussions encountered by researchers on Collaborative Governance in the Social Protection Policy of Karimun Regency can be described as follows:

### 1. Collaborative Governance Process

The Collaborative Governance process is one in which the government collaborates with various parties, including organizations, community groups, and the private sector in making decisions and implementing policies related to social, economic, and environmental issues. The Collaborative Governance process in the Social Protection Policy of Karimun Regency includes the following:

# a. Face Dialogue

In the context of social protection policy in Karimun Regency, Face to Face Dialogue is one of the methods used in the Collaborative Governance process. This dialogue involves various parties, such as local government, representatives of the community, civil society organizations, and the private sector involved in social protection policy. The results of this dialogue process include:

Good social protection policy will help communities achieve a better future and have a positive impact on regional development. The Collaborative Governance process and trust building are the key foundations in developing effective social protection policies that can continually improve community welfare in Karimun Regency.

#### 3. Commitment to Process

- Technology and infrastructure: Adequate technology and infrastructure can help facilitate effective collaboration and coordination. In social protection policymaking, Karimun Regency needs to consider the necessary technology and infrastructure to facilitate better collaboration.

# c. Facilitative Leadership

The application of Facilitative Leadership can influence factors that affect Collaborative Governance in social protection policies in Karimun Regency. Some factors that can be influenced include:

- Effective communication between stakeholders. In Facilitative Leadership approach, leaders act as mediators or facilitators in facilitating effective communication among stakeholders. This can help overcome differences in views or interests that may arise among stakeholders in social protection policy.
- Increased stakeholder participation. Leaders in Facilitative Leadership approach encourage active stakeholder participation in decision-making processes, so stakeholders become involved and feel ownership of social protection policies.
- Cooperation among stakeholders. Facilitative Leadership promotes cooperation among stakeholders inside and outside organizations to achieve common goals. In social protection policy, this can help in building effective collaboration and ensuring that all stakeholders are involved in the policy implementation process.
- Collaborative and participatory decision-making. In Facilitative Leadership approach, the decision-making process is carried out collaboratively and participatively. Leaders act as mediators to help stakeholders reach mutually beneficial agreements. This can help in creating more inclusive social protection policies that can be accommodated by all stakeholders.

By applying Facilitative Leadership, factors affecting Collaborative Governance in social protection policies in Karimun Regency can be overcome, contributing to the creation of effective and inclusive social protection policies.

Based on the research on Collaborative Governance in Social Protection Policy in Karimun Regency, it can be inferred that the collaborative governance approach has significantly contributed to enhancing the effectiveness of social protection policies in Karimun Regency.
